BY-LAW NO. 1377-01

BEING A BY-LAW to adopt Township of Michipicoten Policy No. HR-007:
Council Remuneration.

WHEREAS Section 242 (1) of the Municipal Act, R.S.O. 1990, Chapter M.45 as amended from time to time provides that Councils may pass by-laws with respect to the paying of remuneration to the members of Municipal Council;

AND WHEREAS the Council has reviewed the remuneration paid to the members of Municipal Council for the Township of Michipicoten;

AND WHEREAS this Policy will replace By-Law No. 215-82 and 539-88, in its entirety;

NOWTHEREFORE the Council of the Corporation of the Township of Michipicoten enacts as follows:

1. **THAT** Township of Michipicoten By-Law Nos. 215-82 and 539-88 be and are hereby repealed.
2. **THAT** Policy No. HR-007: Council Remuneration herein attached as Schedule "A" to this By-Law and forming an integral part of this By-Law, be adopted.
3. **THAT** the Reeve and Clerk be and they are hereby authorized to sign this By-Law and to affix the corporate seal thereto.
4. **THAT** this By-Law is enacted upon the third and final reading hereof.

Preamble

- 1.0.0 The Municipal Act, Section 242 (1), RSO 1990, Chapter M.45, provides that the municipality may pass by-laws with respect to the paying of remuneration to the members of Municipal Council.

Policy Statement

- 1.0.0 The Township of Michipicoten wishes to provide for the paying of remuneration to the members of Municipal Council under the authority provided by the Municipal Act.

Section C

Definitions

- 1.0.0 **“Corporation”** shall mean the Corporation of the Township of Michipicoten or its successors.
- 2.0.0 **“Council”** shall mean the Council of the Corporation of the Township of Michipicoten or its successors.
- 3.0.0 **“Head of Council”** shall refer to the Reeve of the Township of Michipicoten or his / her successor.
- 4.0.0 **“Term of Office”** shall be noted as the 1st day of December in a Municipal Election year, until the 30th day of November in the year of the next Municipal Election.
- 5.0.0 **“Members of Council”** shall refer to the Head of Council and Councillors.

Section D

Regulations

1.0.0 Effective Date

- 1.0.1 The payment of remuneration to Members of the Council of the Corporation of the Township of Michipicoten will be effective upon the first day of the term of office.
- 1.0.2 The payment of remuneration to Members of Council will continue the last day of the term of office or until such time as a member ceases to be a Member of Council.

2.0.0 Remuneration Rates

- 2.0.1 The remuneration rate for the Head of Council shall be \$12,711.36 per annum.
- 2.0.2 The remuneration rate for a Councillor shall be \$6,352.68 per annum.

3.0.0 Timing of Payments

- 3.0.1 Annual remuneration for Members of Council shall be paid in twelve, equal, monthly installments.
- 3.0.2 Payments of remuneration for Members of Council shall be paid on the first Friday of each month with each payment being applicable to the month in which it is paid.
