

**THE CORPORATION OF THE  
MUNICIPALITY OF WAWA**

**BY-LAW NO. 3277-20**

**BEING A BY-LAW** to establish and appoint the Northern Nationals Drag Race Committee for the Municipality of Wawa.

**WHEREAS** the Municipal Act, 2001, S.O. 2001, Chapter 25, Section 8(9), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

**AND WHEREAS** the Municipal Act, 2001, S.O. 2001, Chapter 25, Section 8(1), provides the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

**AND WHEREAS** the Municipal Act, 2001, S. O. 2001, Chapter 25, Section 5(3), provides that a municipal power, including a municipality's capacity, rights, powers and privileges under section 9, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

**AND WHEREAS** the Council of the Municipality of Wawa considers it desirable to establish and appoint the Northern Nationals Drag Race Committee for the Municipality of Wawa, hereinafter referred to as the Drag Race Committee;

**NOWHEREFORE** the Council of The Corporation of the Municipality of Wawa enacts the following as a By-Law:

1. **THAT** a Drag Race Committee for the Municipality of Wawa be and is hereby established.
2. **THAT** the duties of the Municipality of Wawa Drag Race Committee shall be to administer and ensure the success of the Northern Nationals Wawa Drag Races. The duties of the Drag Race Committee shall be as follows:
  - (a) To provide the ongoing support and participation in the organization of the Northern National Drag Races.
  - (b) The Wawa Drag Race Committee shall participate in the planning and hosting of the event and shall work with the Municipality as outlined in this agreement.
  - (c) The Wawa Drag Race Committee shall have input into the operations and budgeting decisions for the Northern Nationals Drag Race event, but notwithstanding the number of Municipal representatives on the

Committee, the Municipality shall make all financial decisions and pay all expenses and enter into all contracts necessary for the event in accordance with the approved budget.

- (d) In addition to paragraph (c), all purchases required to operate the event shall be made in accordance with the Municipality's procurement policy
- (e) The Municipality shall be the financial manager for the event and shall keep separate and complete records of income and expenses for the event. This will be shared with the committee.
- (f) Subject to municipal approval, the Drag Race Committee shall determine the type and form of the event advertising, the ticket prices and method of ticket sale, the VIP list, the list of potential sponsors and other matters relating to the hosting of the event.
- (g) The Drag Race Committee will make every effort to acquire the equipment and manpower necessary to complete the conversion of the airport venue into a drag race strip. However, if the committee is unsuccessful in its efforts, and the necessary volunteers are not available, the Municipality agrees to provide the equipment and manpower required to produce the drag race event.
- (h) The Municipality shall obtain any and all required permits and licenses including liquor licenses and any additional insurance if required.
- (i) The continuation of the Drag Race Committee is conditional on the Municipality and Lusville Dragway, or its successors, entering into a satisfactory agreement for the operation of drag races on the event dates.

3. **THAT** the following be appointed as members of the Drag Race Committee for the Municipality of Wawa, with their respective terms as set out opposite their names:

- 4. **THAT** the committee members shall hold office for a term concurrent with the term of the appointing council, or until a successor is appointed, and may be reappointed for one or more further terms.
  
- 5. **THAT** the Clerk of the Municipality of Wawa shall give public notice of vacancies on the committee. Where a vacancy arises in the membership of a committee, the appointing council shall appoint a person to fill the vacancy and to hold office for the unexpired term, except where the unexpired term is less than forty-five days.
  
- 6. **THAT** the Mayor and Clerk be and are hereby authorized to execute this by-law and to affix thereto the corporate seal of the corporation.
  
- 7. **THAT** this by-law shall come into force and effect immediately upon passage.

**READ** a first, second and third time and be finally passed this 4<sup>th</sup> day of February, 2020.
