### **Purpose**

The purpose of this report is to provide Council with a draft 2025 Schedule of F Fees for review and input.

### **Background**

The Municipality of Wawa provides a variety of services and programs with some of the supporting revenues being generated through user fees rather than burdening the municipal tax levy.

As part of the review and update process consideration is given to:

- The needs of the Municipality,
- The levels of service to be provided,
- Best practices,
- Legislative requirements,
- The recommendations of the 10 Year Water Financial Plan prepared by Watson and Associates
- The recommendations of the Long-Term Financial Plan prepared by Watson and Associates

The 2025 Schedule of Fees include adjustments to existing user fees, additions and removals of fees as follows:

Adjustments are highlighted in green with the 2024 fees noted in the left column of the document.

Deleted administrative services have been referred to the Wawa Public Library.

The Town Hall Boardroom (Committee Room) has been removed as this space has been converted into office space.

No changes were made to the Business License section however, the related bylaw is scheduled for review and updating in 2025, the Schedule of Fees may be amended as per the results of this update.

In the past three years the average budgeted expenses for the Community Services and Tourism department are \$1,738,702 which is 5.25 times the average budgeted revenue of \$330,806. Wawa's rates are lower than the 2023 user fees of some communities of similar size. Although MMCC and Arena rates have been adjusted it is recommended that a detailed analysis of expenses and user fees be completed in 2025. This would further satisfy the Wawa Strategic Plan Key Priority LTF-5 Undertake a review of the Wawa Community Centre Operations and User Fees to Ensure Sustainability and update annually.

Water and Wastewater Rates, Section 9.4 and 9.5 are set through the operating budget. In 2025 the increase is expected to be 6% for water rates and 1.9% for wastewater rates. This service is fully funded through user fees.

Sault Ste Marie and Thunder Bay transit fares were reviewed, no changes were made as our fares align with the other two communities.

Some commercial and/or industrial users receive more than the allowed number of pickups as per the current waste collection by-law. Section 11.6 addresses the requirement for additional commercial/industrial pickups as well as setting a reasonable fee. Guidelines regarding scheduling, invoicing etc. for both the municipality and our contractor will be developed and information will be forwarded to affected businesses prior to implementation. The refuse collection bylaw is currently under review with an updated bylaw to be brought to Council in 2025.

No changes were made to the Cemetery Section at this time. This Bylaw is also under review with an update, including fees expected in 2025 which will include changes to our cemetery which include items such as the addition of the columbarium and the cost of a niche.

## Options

Option 1 – Do not increase fees above the 2024 Schedule of Fees and subsidize the increased cost providing services through the municipal tax levy. This option is not recommended as many of the programs and services directly benefit the user only and not the municipality overall.

Option 2 – Apply a larger increase to the fees moving closer to cost recovery for all services and programs. This is not a recommended option as large increases could result in a negative impact on users, particularly those with a lower or fixed income.

Option 3 – This is the preferred option and recommends the adoption of the proposed 2025 Schedule of Fees, which adjusted rates based on independent financial analysis review of peer fees within our region and consideration to residents and Council core values as presented in the August 2023 Strategic Plan.

### **Recommendation**

That the 2025 Schedule of Fees be published for Council review and public input from December 11, 2024 to January 2, 2025, and, after a successful public review period, be brought to the January 14, 2025 Regular Meeting of Council for adoption through by-law.
