If you are considering filing for nomination for Mayor, or Council or School Board Trustee, this Candidate's package will provide you with information needed and the required forms.

## FILING YOUR NOMINATION

### How to File

- Book an appointment with the Clerk or Deputy Clerk by calling 705-856-2244 ext. 223 or email [moneill@wawa.cc](mailto:moneill@wawa.cc) or [hrainville@wawa.cc](mailto:hrainville@wawa.cc)
- Submit Completed Nomination Form and Required Documents, provide I.D. and make payment
- Filing of papers must be done in person
- Original signatures required (no email/fax submissions accepted)

When you fill out the nomination form, write down your name as you want it to appear on the ballot. If you normally go by a different name than your legal first name, you may use that name provided that the clerk agrees.

You do not have to provide all of your names under the box entitled "Given Name(s)" on the form. Only provide the one(s) that you want to appear on the ballot. If your legal name is a single name, you do not have to provide any given names.

### When to File

- During nomination period - May 1 to August 20 - During Office Hours
- Or on Nomination Day – August 21 – Between 9:00 a.m. – 2:00 p.m. Only

### Filing Fees

- Mayor: \$200
- Councillor/Trustee: \$100

**Payment methods:** cash, debit, certified cheque, or money order

**The nomination period begins on May 1, 2026. The last day to file a nomination is Friday, August 21, 2026, by 2 p.m.**

**The clerk has until 4 p.m. on Monday, August 24, 2026, to certify or reject your nomination. The clerk must be satisfied that you are eligible to run in order to certify your nomination. If your nomination is not certified, your name will not appear on the ballot.**

## ELECTION FINANCIAL RESPONSIBILITIES

The Municipal Elections Act, 1996 imposes limitations on the expenses for candidates in municipal elections and imposes requirements on the candidate to report the contributions received and the funds expended.

Detailed information on campaign finances, reporting, contributions, and expenses may be found within the Province of Ontario Candidate Information Guide (link available on municipal website <https://www.wawa.cc/your-government/municipal-election-2026/resources/>). Candidates are encouraged to reference the Municipal Elections Act, 1996 for the exact details.

### When may a candidate conduct fundraising and incur campaign expenses?

The candidate may incur campaign expenses and may accept donations starting on the day they file their Nomination Form.

### What limits are there on campaign spending?

A preliminary maximum campaign expense limit will be provided to the candidate when the nomination is filed. These limits are calculated using a base amount multiplied by the number of eligible electors for each office.

**For reference only, the 2026 maximum spending limits are:**

**Mayor: \$9,273.10**

**Councillor: \$6,783.30**

An Interim Certificate of Maximum Expenses will be issued upon filing of nominations.

A final Certificate of Maximum Campaign Spending Limits will be issued to candidates by September 30, 2026.

A letter has been enclosed in this package for candidates to take to their banking institution to assist in the creation of their campaign bank account.

## CONTRIBUTION LIMITS – FROM YOURSELF AND YOUR SPOUSE

If you are running for municipal council, there is a limit on the total amount that you and your spouse may collectively contribute to your own campaign. The contribution limit is calculated based on the number of electors who are eligible to vote for the office that you are running for. The formula to calculate the limit is:

- for head of council: \$7,500 plus \$0.20 per eligible elector
- for council member: \$5,000 plus \$0.20 per eligible elector

There is a cap of \$25,000. If the formula results in a number greater than \$25,000, the limit will still be \$25,000.

The Clerk will tell you what your self-funding limit is. All of the contributions that you and your spouse make to your own campaign count towards this limit, including:

- contributions of money
- the value of goods or services that you or your spouse donate to the campaign
- the value of any inventory from the previous election that you use again in this campaign

This limit does not apply to school board trustee candidates.

## **FINANCIAL REPORTING REQUIREMENTS**

On or before 2:00 p.m. on March 30, 2027, each candidate shall file the necessary financial reports with the Clerk.

## **CANDIDATE INFORMATION AND PRIVACY**

Under the Municipal Freedom of Information and Protection of Privacy Act (MFIPPA):

- Candidates must consent to release personal information (signed form upon filing)
- The Clerk may publish candidate details

## **ELECTION SIGNS**

## **CAMPAIGNING ON VOTING DAY AND VOTING PLACES**

The Municipal Elections Act, 1996, does not prohibit campaigning on voting day. While there are restrictions on advertising for federal and provincial elections on voting day, these "blackouts" do not exist for municipal council and school board elections.

The Act prohibits the display of campaign material inside a voting place. The "voting place" could include the entire property of a building that has a voting place inside it, including the parking lot. You are not allowed to have campaign brochures, campaign buttons, signs or any other material inside the voting place.

## CANDIDATE LISTS

The voters' list becomes a public document on September 1, 2026. As a candidate, you can request that the municipal clerk give you the part of the voters' list that relates to the office that you are running for. This request must be in writing.

To receive the voters' list from the municipal clerk, you must give the clerk a written acknowledgement confirming that you will:

- only use the list for electoral purposes, not for commercial purposes.
- follow the restrictions set out in the *Municipal Elections Act* for handling the voters' list.
- only share the list with others (such as campaign workers) after obtaining a similar written acknowledgement from them.

## CERTIFICATION OF NOMINATIONS

Section 35 of the Municipal Elections Act, 1996 states:

1) The Clerk shall examine each nomination that has been filed, in accordance with the following timetable:

- i. All nominations filed on or before Nomination Day shall be examined before 4:00 p.m. on the Monday following Nomination Day (August 24, 2026).
- ii. All additional nominations filed under subsection 33(5) shall be examined before 4:00 p.m. on the Thursday following Nomination Day.

2) If satisfied that a person is qualified to be nominated, the Clerk shall certify the nomination by signing the nomination paper.

3) If not satisfied that a person is qualified to be nominated or that the nomination complies with this Act, the Clerk shall reject the nomination.

4) When the Clerk rejects a nomination, he or she shall, as soon as possible, give notice of the fact to the person who sought to be nominated and to all candidates for the office.

5) The Clerk's decision to certify or reject a nomination is final.

**Note: It is the candidate's responsibility to ensure they meet all the qualifications and file the proper nomination paperwork. Each candidate should contact the Clerk to verify that their Nomination Forms are in order.**

## WITHDRAWAL OF NOMINATION

If you decide to withdraw your nomination, you must notify the Clerk or Designate in writing by the close of nominations (2 p.m. August 21, 2026).

If you withdraw your nomination, you are still required to file a campaign financial statement covering all the financial transactions you made in your campaign.

If your campaign did not have any financial transactions, you must file a financial statement reporting this. Your nomination fee will be refunded by the clerk if you file your financial statement by the deadline.

## CHANGING YOUR MIND – RUNNING FOR A DIFFERENT OFFICE

You can only run for one office at a time. If you decide to run for a different office, your first nomination is deemed to be withdrawn when you file your second nomination.

If you decide to run for a different office on the same council or school board, and both offices are elected at large (for example, an office such as the mayor, which everyone in the municipality may vote for), everything (contributions, expenses, etc.) from your first campaign is simply transferred to your second campaign.

## WRAPPING UP YOUR CAMPAIGN

After voting day, remove any election signs that have been put up and take down your campaign website, if you have one. If you would like to keep using your website, remove any references to the campaign. Websites that say “Vote for me” which are left up for years after the election can make it look like you are attempting to campaign for the next election early.

Your campaign must end on December 31, 2026, unless you have a deficit and inform the clerk in writing that you are going to extend your campaign. Once your campaign has ended, you should close your campaign bank account and prepare your campaign financial statement.

The deadline to file financial statements is the last Friday in March. Since March 26, 2027, falls on Good Friday, and March 29 is Easter Monday, financial statements **may be filed with the clerk until 2 p.m. on Tuesday, March 30, 2027.**
