SUBJECT: Report of the Integrity Commissioner
Covering the period from January 1, 2025 to December 31, 2025

Appointment

On October 23, 2019, the Council of The Corporation of the Municipality of Wawa appointed Antoinette Blunt, President, Ironside Consulting Services Inc. as the Municipality's Interim Integrity Commissioner. The appointment was effective October 23, 2019, according to Resolution #SP19047, and effective until February 28, 2020.

On January 28, 2020, the Council of The Corporation of the Municipality of Wawa passed Bylaw 3269-20 appointing Antoinette Blunt, President, Ironside Consulting Services Inc. as the Municipality's Integrity Commissioner from February 29, 2020, until December 31, 2022.

On December 13, 2022, the Council of The Corporation of the Municipality of Wawa passed Bylaw No. 3551-23, appointing Antoinette Blunt, Ironside Consulting Services Inc. as the Municipality's Integrity Commissioner from January 1, 2023, to December 31, 2024.

On January 14, 2025, the Council of The Corporation of the Municipality of Wawa passed Bylaw No. 3761-24, appointing Ironside Consulting Services Inc. as the Municipality's Integrity Commissioner from January 1, 2025, to December 31, 2026.

Municipal Act, 2001

Section 223.6 (1) of the Municipal Act states, that "If the Commissioner provides a periodic report to the municipality on his or her activities, the Commissioner may summarize advice he or she has given but shall not disclose confidential information that could identify a person concerned. 2006, c. 32, Sched. A, s. 98."

Activities During Period – Request for Inquiry

A Request for Inquiry was filed by a member of the public on February 18, 2025, alleging a Councillor violated the Municipal Conflict of Interest Act. The Integrity Commissioner reviewed the matter and concluded this Request for Inquiry was filed under By-Law 3175-19 dated the 19th day of February 2019, and this By-Law has been superseded by a more current By-law, By-Law No. 3593-23, dated the 18th day of April 2023. The Integrity Commissioner found this Request for Inquiry should be dealt with under one of the above processes noted in section 7. By-Law No. 3593-23, dated the 18th day of April 2023, and as such, this Request for Inquiry will no longer be considered or dealt with by the Integrity Commissioner.
