FOR THE PROVISION OF WATER SERVICE:

1. I, the undersigned (hereinafter called the Owner) do hereby request the Municipality of Wawa to make necessary connections and provide water service and/or a private service connection at the premises above listed if the water services connection is not now present or if a water service connection is present, I request that I be allowed to connect my private water services to the service connection and I undertake and agree to be bound by the rules and regulations and general conditions as stated herein and in By-Law No. 3284-20 and as may be established from time to time by the Municipality of Wawa.
2. If Owner is authorizing an Agent to represent and complete request must complete and sign form on page 9.

3. This agreement shall not be binding upon the Municipality of Wawa until accepted by it through its proper officers, and shall not be modified or affected by any promise, agreement or representation, by any agent or employee of the Municipality of Wawa, unless incorporated in writing into this agreement before such acceptance.
4. (a) If an Owner or tenant vacates the above listed premises without the Owner notifying the Municipality of Wawa, the Owner is liable for all subsequent accounts until a new consumer is registered at the vacated location. It is the Owner's responsibility to notify the Municipality of Wawa in writing when he or his tenant vacates the premises where he was registered for water service.

(b) Where the necessary water services and private water services have already been installed, and the cost of such installation fully paid, and the premises for which the supply of water is required is occupied by a tenant, the application for a supply of water to said building must be signed by the Owner of such building.
5. The Owner agrees that on request of the Municipality of Wawa at its discretion, he will make a deposit to be held by the Municipality of Wawa without interest as a guarantee that the Owner will fulfill all terms of this agreement.
6. The Owner will provide all plumbing on the premises and all water lines connecting premises with the point of connection with the Municipality of Wawa water service at the property lines and maintain the same in efficient condition with proper devices.
7. The Owner will install a water meter supplied by the Municipality of Wawa as per By-Law No. 3284-20.
8. The rates charged for water service are subject to change at any time.

9. This agreement shall continue in force from year to year until terminated by a notice in writing, given by either party hereto at least one month before the end of term or any year term thereafter.
10. The Owner agrees not to make any changes in or additions to his plumbing or connecting water line after the same has been installed by the Owner and inspected by the Superintendent except with the written consent of the Municipality of Wawa.
11. It is agreed that the signatures of the parties hereto shall be binding upon their successors or assigns, and that the vacating of the premises herein named shall not release the Owner from this Agreement, except at the option, and by written consent of the Municipality of Wawa.
12. The Consumer may apply for an exemption from installing his private water service at the minimum 2.13 metre cover in accordance with By-Law No. 3284-20 and by completing pages 7 and 8.
13. The Owner agrees that if his application for exemption from minimum 2.13 metre cover is approved the service connection shall be installed in strict accordance with the appropriate clause as stated in the Application for Exemption from minimum 2.13 metre cover of Private Water Service Connection.
14. The Owner agrees that if the Municipality allows him to connect to the water distribution system prior to the system being charged he is liable for all the cost of repair if it is found that his private service connection leaks once the system is charged.
15. The Owner agrees to make such repairs as may be designated by the Superintendent from time to time to his private service or interior house plumbing that may eliminate leaks.


