GENERAL PROVISIONS

- 1. The Road Authority may change or cancel this Permit at any time if it is deemed necessary.
- 2. Bridge Weight and Clearance Limits shall be obeyed.

8. This Permit must accompany the vehicle at all times.

- 3. The Applicant may be required to file one (1) or more Bonds with this Application in such an amount as, in the opinion of the Road Authority, is sufficient to cover the cost of repairing any possible damage to the highway resulting from the hauling.
- 4. The Applicant, his Heirs, Executors, Administrators or Assigns hereby agrees to indemnify and save harmless the above noted Road Authority from any action, claim damages or loss whatsoever arising from operations carried out under this Permit.
- 5. The Applicant will be required, at their expense throughout the duration of this Permit, to control within reasonable limits to the satisfaction of the Ministry of Transportation any damage done to the roads or dusty conditions caused as a result of the issuance of this Permit. If this Applicant does not comply with this provision within 24-hours of verbal notice from the Ministry of Transportation, the Municipality of Wawa, without further notice, may have these conditions corrected immediately and all cost incurred shall be charged to the Applicant, and the Municipality of Wawa may cancel this Permit immediately. This Permit is issued under the Authority of the following:

Municipality of Wawa By-Law No. 3831-25 and the Highway Traffic Act, RSO 1990, c H.8 Part VII, Section 110

- 6. The overweight privileges contained in this Permit are void during any period when, in the opinion of the Road Authority, the roads indicated on this Permit show signs of deteriorating.7. No movements to be made on Sundays.
